### Summary FIRA Comments


We compliment Schindler Liften on initiatives undertaken. Please find a summary of our comments as published in the FIRA Platform below:

- **Balance & Completeness:** Management approach has been disclosed, we encourage Schindler Liften to complete the management approach by disclosing clear objectives on all relevant CSR issues. Practices are focused on ethical compliance, carbon footprint inventory, and internships. We encourage Schindler Liften to expand scope to include production and report relevant CSR issues such as health and safety, pollution, circular economy, climate change, and sustainable procurement, including conflict minerals. Furthermore we encourage Schindler Liften to disclose practices on safe and energy efficient products and social issues such as social return and employability.
- **Code of Conduct:** A company code of conduct is in place.
- **Commitment to CSR:** Schindler Liften has committed to the template CSR declaration, including commitment to all CSR principles and to progress on material issues. We encourage Schindler Liften to work on a company specific declaration.
